Consignment Policy (Effective Jan 1, 2012) v-18

Consigning: Items accepted on Monday, Wednesday and Friday, or by appointment.

- * Items suitable for consignment are women’s clothing, lingerie, shoes, accessories, purses, and jewelry. Vintage and Retro clothing and accessories. High end mens clothing, shoes and accessories.
- * All items must be in excellent or like-new condition, in style, clean, pressed and on hangers with no stains/fading, no damage/tears, no odors, no pet hair.
- * Acceptance of any item for consignment is at the sole discretion of Repeat Boutique and requires a signed contract. Repeat Boutique may terminate any contract for any reason at any time.
